To approve the amendment in Clause- 3 (b) "Matters which are necessary for furtherance of the objects specified in clause 3(a) are" of Memorandum of Association of Company by insertion of Clause 49 after existing Clause 48 regarding setting-up facilities for generation of power for captive consumption of the Company:

To consider and if thought fit, to pass, with or without modification(s), the following resolutions as Special Resolutions:

"RESOLVED THAT pursuant to the provisions of Sections 13 and all other applicable provisions, if any, of the Companies Act, 2013 ("Act") read with the rules made thereunder, including the Companies (Incorporation) Rules, 2014, and other applicable rules, if any, the provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, and subject to such other approvals, consents, permissions and sanctions, as may be necessary from the appropriate statutory, regulatory or governmental authorities, and subject to such conditions and modifications as may be prescribed while granting such approvals, consents, permissions and sanctions, which may be agreed to by the Board of Directors of the Company (hereinafter referred to as the "Board", which term shall be deemed to include any Committee thereof or any person(s) authorized by the Board to exercise its powers, including the powers conferred by this Resolution), the consent of the Members of the Company be and is hereby accorded for alteration of Clause 3(b) of the Memorandum of Association of the Company titled "Matters which are necessary for furtherance of the objects specified in Clause 3(a)" by inserting the following new Clause 49 immediately after the existing Clause 48;

Clause 49: To establish, acquire, construct, install, operate, maintain, renovate, modernize, manage and use captive power generation plants and facilities for generation, storage, transmission, wheeling, distribution and consumption of electricity or any other form of energy for the Company's own use and allied purposes, whether from conventional sources including thermal, hydro and nuclear (subject to applicable laws) or from renewable and non-conventional sources including solar, wind, tidal, geothermal, biomass, hydrogen, waste-to-energy or any other source of energy, together with all associated equipment, infrastructure and utilities, subject to applicable laws.

RESOLVED FURTHER THAT upon the aforesaid alteration becoming effective, the Memorandum of Association of the Company be and is hereby amended accordingly;

RESOLVED FURTHER THAT any Executive Director of the Company and/or the Company Secretary, be and are hereby severally authorized, for and on behalf of the Company, to do all such acts, deeds, matters and things as may be deemed necessary, desirable, proper or expedient, including settling any question, difficulty or doubt that may arise in relation thereto, and to sign, execute and file all necessary applications, e-forms, returns, declarations, documents and writings with the Registrar of Companies and/or any other statutory, regulatory or governmental authority, and to make such modifications or alterations as may be required by any such authority or otherwise considered necessary for the purpose of giving effect to this Resolution, and to delegate all or any of the powers herein conferred to any officer(s) or authorized representative(s) of the Company, to the extent permitted under applicable law."

NOTES FOR SHAREHOLDERS FOR EOGM:

1. The Government of India, Ministry of Corporate Affairs has allowed conducting the General Meeting ("Meeting") through Video Conferencing ("VC") or Other Audio-Visual Means ("OAVM"), and dispensed the personal presence of the members at the meeting. Accordingly, the Ministry of Corporate Affairs issued the General Circular No. 14/2020 dated April 8, 2020, the General Circular No. 17/2020 dated April 13, 2020 in relation to "Clarification on passing of ordinary and special resolutions by companies under the Companies Act, 2013 and the rules made thereunder", and General Circular No. 20/2020 dated May 5, 2020 read with General Circular No. 02/2021 dated January 13, 2021, General Circular No. 2/2022 dated May 5, 2022, General Circular No. 09/2023 dated September 25, 2023, General Circular No. 09/2024 dated September 19, 2024 and General circular No. 03/2025 dated September 22, 2025 prescribing the procedures and manner of conducting the Extra Ordinary General Meeting through VC/ OAVM. In terms of the said circulars, the Extra Ordinary General Meeting (EOGM) of the members will be held through VC/OAVM. Hence, members can attend and participate in the EOGM through VC/OAVM only.

The detailed procedure for participation in the meeting through VC/OAVM is as per note no. 14 and available at the Company's website www.katariaindustries.co.in. The deemed venue for the EGM shall be the Registered Office of the Company.

2. A statement pursuant to Section 102(1) of the Act, relating to the Special Business to be transacted at the EGM is annexed hereto.
3. Though, pursuant to the provisions of the Act, a Member is entitled to attend and vote at the EOGM is entitled to appoint a proxy to attend and vote on his/her behalf, since this EOGM is being held pursuant to the Circular No. 14/2020 dated April 8, 2020, issued by the Ministry of Corporate Affairs, the facility to appoint proxy to attend and cast vote for the members is not available for this EOGM and hence the Proxy Form and Attendance Slip are not annexed to this Notice.
4. Institutional/Corporate Shareholders (i.e. other than individuals/HUF, NRI, etc.) are required to send a scanned copy (PDF/JPEG Format) of its Board Resolution or governing body Resolution/Authorization etc., authorizing its representative to attend the Extra Ordinary General Meeting through VC/OAVM on its behalf and to vote through remote e-voting. The said Resolution/Authorization shall be sent to the Scrutinizer by email through their registered email address to csanandlavingia@gmail.com with copies marked to the Company at cs@katariaigroup.co.in and to National Securities Depository Limited (NSDL) at evoting@nsdl.com.
5. The attendance of the Members attending the EGM through VC/OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Companies Act, 2013.
6. Since the EGM will be held through VC/OAVM, the route map of the venue of the Meeting is not annexed hereto.

7. In line with the aforesaid Ministry of Corporate Affairs (MCA) Circulars and SEBI Circular dated May 12, 2020 read with Circular dated January 15, 2021, the Notice of EGM along with other documents is being sent only through electronic mode to those Members whose email addresses are registered with the Company/ Depositories. Member may note that Notice has been uploaded on the website of the Company at www.katariaindustries.co.in. The Notice can also be accessed from the websites of the Stock Exchange i.e. NSE at www.nseindia.com and the EGM Notice is also available on the website of NSDL i.e. www.evoting.nsdl.com.
8. In case of joint holders attending the EGM together, only holder whose name appearing first will be entitled to vote.
9. Members seeking any information with regard to any matter to be placed at the EGM or who would like to ask questions or registered themselves as Speaker, are requested to write to the Company mentioning their name demat account number/folio number, email id, mobile number at cs@katariaigroup.co.in on or before August 16, 2026 so as to enable the management to keep the information ready. The Company reserves the right to restrict the number of speakers depending on the availability of time for the EGM.
10. 12. Members are requested to intimate changes, if any, pertaining to their name, postal address, email address, telephone/ mobile numbers, Permanent Account Number (PAN), mandates, nominations, power of attorney, bank details such as, name of the bank and branch details, bank account number, MICR code, IFSC code, etc., to their DPs in case the shares are held in electronic form and to BSPL in case the shares are held in physical form.
13. As per the provisions of Section 72 of the Act, the facility for making nomination is available for the Members in respect of the shares held by them. Members who have not yet registered their nomination are requested to register the same by submitting Form No. SH-13. Members can contact their DP in case the shares are held in electronic form and to BSPL in case the shares are held in physical form.
14. **PROCESS AND MANNER FOR MEMBERS OPTING FOR VOTING THROUGH ELECTRONIC MEANS AND PARTICIPATING AT THE EXTRA ORDINARY GENERAL MEETING THROUGH VC/OAVM:**
 - i. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 (as amended), and the Circulars issued by the Ministry of Corporate Affairs dated April 8, 2020, April 13, 2020, May 5, 2020 and SEBI Circular dated May 12, 2020, the Company is providing facility of remote e-voting to its Members in respect of the businesses to be transacted at the EGM. For this purpose, the Company has entered into an agreement with NSDL, as the Authorised e-voting agency for facilitating voting through electronic means. The facility of casting votes by a member using remote e-voting as well as e-voting system on the date of the EGM will be provided by NSDL.
 - ii. There being no physical shareholders in the Company, the Register of members and share transfer books of the Company will not be closed. Members whose names are recorded in the Register of Members or in the Register of Beneficial Owners maintained by the Depositories as on the Cut-off date i.e. Wednesday, August 19, 2026, shall be entitled to avail the facility of remote e-voting as well as e-voting system on the date of the EGM. Any recipient of the Notice, who has no voting rights as on the Cut-off date, shall treat this Notice as intimation only.
 - iii. A person who has acquired the shares and has become a member of the Company after the dispatch of the Notice of the EGM and prior to the Cut-off date i.e. Wednesday, August 19, 2026, shall be entitled to exercise his/her vote either electronically i.e. remote e-voting or e-voting system on the date of the EGM by following the procedure mentioned in this part.
 - iv. Members may cast their votes on electronic voting system from any place (remote e-voting). The remote e-voting period will commence at 09:00 a.m. on Sunday, August 23, 2026 and will end on 05:00 P.M. on Tuesday, August 25, 2026. In addition, the facility for voting through electronic voting system shall also be made available during the EGM. Members attending the EGM who have not cast their vote by remote e-voting shall be eligible to cast their vote through e-voting during the EGM. Members who have voted through remote e-voting shall be eligible to attend the EGM, however, they shall not be eligible to vote at the meeting.
 - v. Once the vote on a resolution is cast by the member, he/she shall not be allowed to change it subsequently or cast the vote again.
 - vi. The voting rights of the members shall be in proportion to their share in the paid-up equity share capital of the Company as on the Cut-off date i.e. Wednesday, August 19, 2026.
 - vii. The Company has appointed M/s. ALAP & CO. LLP, Practicing Company Secretaries (FRN: L2023GJ013900) to act as the Scrutinizer for remote e-voting as well as the e-voting on the date of the EoGM in a fair and transparent manner.

INSTRUCTIONS FOR CASTING VOTES BY REMOTE E-VOTING

The remote e-voting period begins on Sunday, August 23, 2026 and will end on 5:00 P.M. on Tuesday, August 25, 2026. The remote e-voting module shall be disabled by NSDL for voting thereafter. The Members whose names appear in the Register of Members / Beneficial Owners as on the record date (cut-off date) i.e. Wednesday, August 19, 2026 may cast their vote electronically. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date being Wednesday, August 19, 2026.

How do I vote electronically using NSDL e-Voting system?

The way to vote electronically on NSDL e-Voting system consists of "Two Steps" which are mentioned below:

Step 1: Access to NSDL e-voting system:

A) Login method for e-Voting for Individual shareholders holding securities in demat mode

In terms of SEBI circular dated December 9 2020 on e-Voting facility provided by Listed Companies Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. - 2) Select "EVEN" of company for which you wish to cast your vote during the remote e-Voting period.
- 3) Now you are ready for e-Voting as the Voting page opens.
- 4) Cast your vote by selecting appropriate options i.e. assent or dissent, verify/modify the number of shares for which you wish to cast your vote and click on "Submit" and also "Confirm" when prompted.
- 5) Upon confirmation, the message "Vote cast successfully" will be displayed.
- 6) You can also take the printout of the votes cast by you by clicking on the print option on the confirmation page.
- 7) Once you confirm your vote on the resolution, you will not be allowed to modify your vote.

EXPLANATORY STATEMENT

(Pursuant to Section 102 (1) of the Companies Act, 2013 and Secretary Standard 2 on General Meetings)

Item No. 1:

TO APPROVE THE AMENDMENT IN CLAUSE- 3 (B) "MATTERS WHICH ARE NECESSARY FOR FURTHERANCE OF THE OBJECTS SPECIFIED IN CLAUSE 3(A) ARE" OF MEMORANDUM OF ASSOCIATION OF COMPANY BY INSERTION OF CLAUSE 49 AFTER EXISTING CLAUSE 48 REGARDING SETTING-UP FACILITIES FOR GENERATION OF POWER FOR CAPTIVE CONSUMPTION OF THE COMPANY: SPECIAL RESOLUTIONS

The Company owns and operates a 1.60 MW wind power plant situated at Village Ratedi, District Dewas, Madhya Pradesh and a 1 MW solar power plant situated at Ratlam, Madhya Pradesh. The electricity generated from the aforesaid captive power generating facilities is utilized for captive consumption at the Company's manufacturing facility located at Ratlam, District Ratlam, Madhya Pradesh.

Pursuant to the provisions of the Electricity Act, 2003, the rules and regulations framed thereunder, and the applicable guidelines, policies and directions issued by the Government of Madhya Pradesh and the competent electricity regulatory authorities governing captive generating plants and captive consumption of electricity, it is, inter alia, necessary that the Memorandum of Association of the consumer company contains an enabling object authorizing the generation, storage, transmission, wheeling, distribution and consumption of electricity or other forms of energy for captive use and allied purposes.

The Board of Directors consider it appropriate, in the interest of good corporate governance and regulatory compliance, to suitably amend Clause 3(b) of the Memorandum of Association by inserting an enabling object clause specifically authorizing the establishment, acquisition, operation and management of captive power generation facilities and all activities ancillary or incidental thereto. The proposed amendment is clarificatory and enabling in nature and is intended to align the Memorandum of Association with the Company's existing operations as well as its present and future business requirements, while ensuring compliance with the applicable provisions of the Electricity Act, 2003 and other applicable laws.

Accordingly, at its Meeting held on August 4, 2026, the Board of Directors approved, subject to the approval of the Members of the Company, the proposed alteration of Clause 3(b) of the Memorandum of Association by insertion of the new Clause 49, in the manner set out in the accompanying Special Resolution.

In terms of the provisions of Section 13 and other applicable provisions, if any, of the Companies Act, 2013, read with the rules framed thereunder, any alteration of the Objects Clause of the Memorandum of Association requires the approval of the Members by way of a Special Resolution.

A copy of the existing Memorandum of Association together with the proposed amended Memorandum of Association indicating the proposed alteration will be available for inspection by the Members during business hours on all working days from the date of circulation of this Notice up to the date of the General Meeting and shall also be available electronically for inspection by the Members in accordance with the applicable provisions of the Companies Act, 2013 and the Secretarial Standards issued by the Institute of Company Secretaries of India.

None of the Directors, Key Managerial Personnel of the Company or their respective relatives is, in any way, concerned or interested, financially or otherwise, in the Special Resolution set out at Item No. 1 of the accompanying Notice, except to the extent of their shareholding, if any, in the Company.

The Board of Directors is of the opinion that the proposed amendment to the Memorandum of Association is in the best interests of the Company and recommends the Special Resolution set out at Item No. 1 of the accompanying Notice for approval by the Members.
